

QOPI® Certification Application Fees for Practices Outside the United States

For QOPI® Certification, cost is determined by the number of physicians* (defined below) at a participating practice, plus a fee based on the number of practice locations that administer antineoplastic therapy. For applicants outside of the United States, there are additional fees that are country dependent. The applicant practice is responsible for the costs of the On-Site Survey including flight fees, hotels, and ground expenses for up to 2 ASCO representatives. Additional fees for legal review may be assessed for applicants outside of the United States. Payment should only be sent after staff approval in the QCP Application, and the invoice is generated. Each application fee covers the duration of the 3-year Certification term (if Certification is awarded). Application fees are non-refundable.

*Physician calculation: the number of physicians is determined by a unique count of the following physicians (without proration) who prescribe antineoplastic therapies including oral oncolytic therapies for the treatment of a cancer diagnosis: Hematology, Hematology/Oncology, and Medical Oncology physicians, Gynecologic Oncology physicians, and physicians of other specialties.

Flights will be booked through ASCO <u>Direct Travel</u> services 2 months prior to survey to accommodate decreased pricing and visa applications. Countries may request to purchase flights directly if restrictions exist.	\$6,000 (EST.)
Accommodations	Travel costs to be arranged and covered directly by practice	Meals, hotel, and ground transportation to be provided directly by host country to accommodate up to two ASCO representatives, ASCO Surveyor(s) and/or MD reviewer.	No Fee – Cost Varies
